CV: Lee Kim Siang is the present Chairman for Thye Hua Kwan Group of Charities that includes Thye Hua Kwan Moral Society (**THK**MS), Thye Hua Kwan Moral Charities (THKMC), Ang Mo Kio-Thye Hua Kwan Hospital (AMK-THK Hospital), and THK Nursing Home.

A firm advocate for the underserved, under Kim Siang' stewardship, Thye Hua Kwan was commended by the late President of the Republic of Singapore, S. R. Nathan, as one of the leading social service organisations during the 2003 severe acute respiratory syndrome (SARS) outbreak in Singapore. THK, its staff and volunteers were at the forefront of the fight against SARS by offering social services, including counselling and free meals to quarantined families.

A notable charity and community leader, Kim Siang is active and has served on various government boards and committees. From 2012 to 2014, he was a Councillor with the North East Community Development Council (CDC) and a Board Member of the National Council of Social Services (NCSS).
